## Wedding Agreement

My goal is to document each priceless moment of your wedding day with great focus on the details of the wedding preparation, ceremony, reception and any before and after special customs. Emotions speak louder than words and I strive to capture them in an artistic fashion. I combine candid with formal and traditional photography. I'll tell the story of your wedding day in my photography through my lens!

A link of the album with a private password will be provided for you and for family and friends of the bride and groom to view and order their favorite moments. Please allow up to 4 weeks (business days) for your link with your album to be delivered to you after your wedding day.

A Day Coordinator is complimentary provided to you for your wedding day, however, if you have a coordinator, ours will step back in her position.

All Downloadable images are a medium, high resolution file. Can print up to sizes 8 x 10. All other sizes will need to be ordered through Captured Moments by Christine. All downloadable images are a non-refundable final sale.

Additional prints may be ordered separately. A \$500 /\$600 non-refundable retainer is required to book your date and save your date. The retainer will be applied to the total package price. Please allow 4 weeks from the wedding date for delivery of your proofs which will be emailed to you in a private album with password.

\*If you need more hours added to your day, you will be responsible for paying the \$175 each hour before leaving the ceremony / reception. A travel fee of \$30 per hour is also required for any wedding outside Victoria County. A room / board fee of \$100 will also be added for room & board and lunch for weddings out of town.

Typical shooting time starts two hours prior to ceremony time. Please include this time in your packages.

### - Terms -

**Limitation of Liability:** If Photographer cannot perform this Agreement in whole or in part due to circumstances outside of the Parties' control, such as sudden injury or acts of God, then Photographer will return all retainers and fees to the Client(s) but shall have no further liability with respect to this Agreement. This limitation on liability shall also apply in the event that photographic materials are damaged in processing, lost through camera malfunction, lost in the mail, or otherwise lost or damaged without fault on the part of Photographer. Photographer is not liable for any harm that results during any photoshoot or photography except to the extent required by law. In no event shall photographer be liable for any emotional harm to the Client(s) or any other party resulting from Photographer's services or lack thereof.

**Inability to Perform:** In the event of Photographer's foreseeable illness, conflict or inability to perform, Client agrees that Photographer will assign and delegate performance and obligations of this Agreement to another professional photographer. In the event that Photographer cannot perform or the event does not take place as anticipated by Client or as established in this Agreement, Photographer is not required to service a later event or reproduction.

**Exclusivity:** It is understood and agreed that no other photographer will be allowed to photograph or take pictures at the event while Photographer is working, unless otherwise agreed by the Parties in writing. It is understood that a family member with a camera should not get in the way while Photographer is working.

**Payment:** A payment provided by client holds date and time with signed agreement. A retainer of \$500 / \$600 is due at the signing of this agreement or at another time agreed upon by both parties. This is a NON-REFUNDABLE RETAINER. Should CLIENT cancel or otherwise breach this Agreement, all monies paid by client shall be liquidated for damages of company time. If a retainer fee is not paid, Captured Moments by Christine has the right to give your wedding date to the next party of interest. The CLIENT shall also be responsible for payment of any materials/charges incurred up to time of cancellation. Otherwise, the retainer shall be applied towards the Final Total, with the remainder of charges payable in full, two weeks prior to the date of the event. If your date is cancelled and you reschedule to another date, a new deposit will be required to book the new event date.

**Intellectual Property Rights:** All photos and images taken by Photographer and/or his/her assistant remain the sole, copyrighted, intellectual property of Photographer, even after payment by Client. Photographer may reproduce, use and distribute the photos and images for any personal, business, marketing or studio purpose.

**Discretion:** Client understands and agrees that Client is hiring Photographer to perform Photographer's services in Photographer's own discretion and style. Client has no authority to control the manner in which Photographer takes photos. Client has no right to rescind this Agreement in any way if Client is not satisfied with Photographer's photography. Captured Moments by Christine does not guarantee satisfaction of photos and is not liable for the unsatisfactory of the client.

**Restrictions:** Client shall not modify or otherwise alter Photographer's photos. Client is encouraged to online post the photos optimally sized for web on social media. Client shall not post physically or in digital form, including on any social media website, blog or application, any of Photographer's photos without attributing Photographer. Client shall never distribute or make available for download or reproduction any of Photographer's photos without written consent of Photographer unless the photos include Photographer's watermark. Client shall not publish photos without Photographer's written consent.

**Archiving:** Photographer will archive digital files of all photos taken for Client for up to two years. Photographer does not guarantee backup photographs, prints or data after this time.

**Completion Of Images:** Images are expected to be prepared for proofing within 2-4 weeks of the event date. A link for proofing will be emailed to the client for proofing. A Downloadable Album may will be sent to you immediately. Printed items and albums may require additional time.

**Signed & Dated:** I, the undersigned Client, warrant that I am competent to contract in my own name. I confirm that I have read this Agreement prior to its execution and I am fully familiar with its contents. This agreement shall be binding on me and my heirs, legal representatives and assigns. I certify that I have received a complete copy of this agreement. I hereby agree to the terms of this agreement.
